- Your dog must be current on Distemper, Bordetella and Rabies vaccinations, be on a flea preventative program, and be free of parasites to attend our Doggy Daycamp. We will need to see documentation from your vet regarding these requirements.
- Your dog must be spayed or neutered to participate in Doggy Daycamp.
- Your dog's attendance at Doggy Daycamp is not without risk. Every effort will be made by the Keene Doggy Daycamp and Boarding training staff to provide a safe environment for your dog. If your dog requires emergency medical attention, we will contact you immediately and transport your dog to your vet or the after-hours, on-call vet.
- You are responsible for any damage or injury incurred while your dog is at Daycamp. Vet charges due to injury to your dog or injury to another dog caused by your dog will be the responsibility of you and the owner of the other dog.
- Your dog's acceptance into your Daycamp is the sole discretion of the Keene Doggy Daycamp and Boarding staff. If your dog is disruptive while at the Daycamp, he/she will not be able to return to Daycamp until the problem is resolved.
- All dogs must be leashed while on Keene Doggy Daycamp/Fast Friends property. This includes travel from the car to inside the building and vice versa. This is for the safety of your dog.
- **All dogs must be picked up by 6pm or they will incur a boarding charge and be boarded at the kennel for the evening.**
- **All reservations must be held with a credit card. If you cancel your reservation within 48 hours of when it starts, you will be charged 50% of the entire planned stay.**

I, the undersigned, agree to the above, accept full responsibility for the acts of my dog while at Daycamp and release Keene Doggy Daycamp and Boarding Facility and its staff from any and all claims of liability.

This is a Contract between **Keene Doggy Daycamp and Boarding** (hereinafter called "Kennel") and the pet owner whose signature appears below (hereinafter called "Owner").

1. Owner agrees to pay the rate for boarding in effect on the date pet is checked into the kennel (as posted in office).
2. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the pet during the time said pet is in the care of Kennel.
3. Owner further agrees that the pet shall not leave Kennel until all charges are paid to Kennel by Owner.
4. By signing this Contract and leaving his pet with Kennel, Owner certifies to the accuracy of all information given about said pet that Kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$200 per animal boarded. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of Kennel.
5. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
6. Owner specifically represents to Kennel that the pet has not been exposed to rabies, distemper, parvo virus or other contagious diseases within a thirty day period prior to boarding.
7. All charges incurred by Owner shall be payable upon drop-off of pet, or when billed by Kennel at the address listed on Contract. Kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding the pet at Kennel. If Owner does not pick up the pet within 15 calendar days after the day the pet was due to be picked up, the pet shall be deemed to be abandoned.
8. If the pet becomes ill or if the state of the pet's health otherwise requires professional attention, the Kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the pet, and the expenses thereof shall be paid by Owner.
9. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of Owner and Kennel.
10. Any controversy or claim arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled by arbitration in accordance with the rules of the American Arbitration Association, and judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of this award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.

The Kennel reserves the right to treat your dog with flea/tick preventative if the Kennel finds the dog to be infested with fleas/ticks. The Owner shall incur the full cost of the flea/tick treatment.
